Customer and Credit Application Terms and Conditions

This Credit Application ("Application") is entered into between Pulsar International (including its successors and affiliates, "Pulsar") and the Applicant named above ("Applicant"). The Applicant acknowledges that the information provided herein, including the Applicant's financial statement, is furnished for the purpose of securing credit from time to time with Pulsar. The Applicant represents and warrants that the information provided is true, correct, and accurately reflects the Applicant's financial condition. The Applicant authorizes Pulsar to obtain credit and financial information about the Applicant at any time and from any source. Additionally, the Applicant authorizes Pulsar to contact the supplier and financial references listed herein and grants permission for those references to release information regarding the Applicant's credit history.

ENTIRE AGREEMENT: This Credit Application, along with the terms and conditions specified in Pulsar's quotations, invoices, and delivery tickets (which are incorporated by reference), constitutes the entire agreement between the parties and supersedes any conflicting terms and conditions that may appear in any purchase order submitted to Pulsar by the Applicant. The Applicant agrees to be bound by such terms and conditions.

TERMS OF PAYMENT: In consideration of Pulsar extending credit to the Applicant, the Applicant agrees to adhere to the payment terms specified on Pulsar's invoices for all materials and/or services provided. All accounts are due and payable at the remittance address shown on the Pulsar invoice. Pulsar is also authorized to accept credit cards for Auto-Debit processing on the Flexxbill Airtime Billing System. Unless accompanied by specific remittance instructions, the Applicant agrees that Pulsar may apply all unspecified payments at its discretion. Any balances not paid according to the terms stated on the Pulsar invoice are subject to a service charge of 1.5% per month or the maximum rate permitted by law, whichever is less, and such charges shall be paid by the due date specified on the invoice. A portion of a month shall be treated as a full month for the purpose of calculating service charges and interest. A waiver of any service charge or interest for one month shall not constitute a waiver of such charges in the future. The Applicant further agrees that with respect to such charges, the Applicant and Pulsar are parties to a written contract. The Applicant agrees to pay a reasonable fee, not to exceed the maximum allowed by state law, for any returned checks or those dishonored for any reason. For credit card transactions, certain fees up to 3% may apply. Additional fees may apply for customers requiring invoices submitted to proprietary portals for processing.

TRUST: The Applicant agrees that all funds owed to or received by the Applicant from any source, as a result of materials supplied by Pulsar International, shall be held in trust for the benefit of Pulsar. The Applicant agrees to promptly remit such funds to Pulsar International or its affiliates. Upon request, the Applicant shall irrevocably assign to Pulsar International its accounts receivable from any source, to the extent that such receivables result from materials supplied by Pulsar International.

CREDIT LIMIT: The Applicant may, from time to time, be granted a credit limit that exceeds the limit initially requested by the Applicant. If the credit limit is exceeded, the Applicant shall remain liable for the full amount due, including any amount in excess of the credit limit, and acknowledges that Pulsar International shall have no liability arising from the credit limit being exceeded.

ASSIGNMENT: The Applicant agrees not to factor, sell, or assign the debt related to the credit granted by Pulsar International under this Application. The Applicant further agrees to promptly notify Pulsar International in writing of any changes to the Applicant's legal entity, legal name or status, place of business, principals and/or owners, as well as any terminated employees who are no longer authorized to purchase on the account.

ECOA NOTICE: The Equal Credit Opportunity Act (ECOA) prohibits credit grantors from discriminating against credit applicants based on race, color, religion, national origin, sex, marital status, or age. The Federal Trade Commission administers compliance with the ECOA.

FCRA NOTICE: In accordance with the Fair Credit Reporting Act (FCRA), the undersigned hereby consents to Pulsar International's use of a consumer credit report on the undersigned from time to time, in order to evaluate the current and ongoing creditworthiness of the Applicant in connection with the extension of business credit.

GOVERNING LAW AND VENUE: The parties agree this Agreement was executed in New York and the law of the State of New York shall govern the interpretation of this Agreement. Customer agrees that any legal proceeding commenced by either party against the other arising in anyway concerning this agreement shall only be brought in state court in New York. Further, both parties submit to such jurisdiction and waive any objection to venue and/or claim of inconvenient forum.

DISPUTE RESOLUTION: Any dispute arising out of this Application shall be resolved directly with Pulsar International. The Applicant agrees to reimburse Pulsar International for all costs of collection, including, but not limited to, reasonable attorneys' fees, collection agency fees, expenses, and costs associated with filing foreclosure actions on liens resulting from the Applicant's nonpayment.

Applicant understands that submission of this application does not authorize credit or completion of customer onboarding process until approved by Pulsar management.
